INTERMEDIATE 32 Count 4 Walls Choreographed by: Tan Candy Choreographed to: Koi ni Ochite (Fall In Love) by Akiko Kobayashi

### Step back on L & sweep R from front to back 2&34& Step R behind L, step L to L side, cross R over L, step L to L side, step R beside L 5&6& Cross L over R, step R to R side, step L behind R, step fwd on R making 1/4 turn R (3) 78 Step fwd on L, pivot 1/2 turn R taking weight on R (9) Section 2 Cross Back Back, Cross 1/4 Turn Side, Cross Rock Side, Sway x2 12& Cross L over R, step back diagonally on R, step back diagonally on L Cross R over L, step back on L making 1/4 turn R (12), step R to R side 34& Cross rock L over R, recover weight on R, step L to L side 56& Sway R, sway L & drag R to L 78 Section 3 R Nightclub Basic, Rolling Vine, Mambo 1/2 Turn, Fwd Rock 12& Step R to R side, rock L behind R, recover weight on R TAG (2 counts) After Count 18& of Wall 6 (6:00), restart after TAG (6:00) 3&4 Step fwd on L making 1/4 turn L (9), step back on R making 1/2 turn L (3), step L to L side making 1/4 turn L (12)

Back, Behind Side Cross, Side Together, Weave 1/4 Turn, Step Pivot 1/2 Turn

- 5&6 Cross rock R over L, recover weight on L, step fwd on R making 1/2 turn R (6)
- 78 Rock fwd on L, recover weight on R & drag L to R

### RESTART After Count 24 of Wall 3 (12:00)

### Back, Sailor 1/4 Turn, Cross Side, Back Rock, Sway x2 Section 4

- 12&3 Step back on L & sweep R from front to back, step R behind L, step L beside R making 1/4 turn R (9), step fwd on R & sweep L from back to front
- 4 & 5 6 Cross L over R, step R to R side, rock L behind R, recover weight on R
- Step L to L side & sway L, sway R & drag L to R 78

## TAG (2 counts) After Count 18& of Wall 6 (6:00), restart after TAG (6:00)

Step L to L side & sway L, sway R & drag L to R 12
